## 4) NOTIFICATIONS AND DECISIONS

The match of the 13th round, between HC Tatran and HC Vardar, was not played in a regular period on February 3<sup>rd</sup> 2014., due to bad weather and the closure of the highway Novi Sad - Subotica.

In accordance with Article 17.4 and 17.5 of SEHA GAZPROM SOUTH LEAGUE Proposition match is postponed for 19.02.2014.

The term was negotiated and agreed in accordance with the Calendar of EHF and SEHA League, with representatives of both clubs

On February 8<sup>th</sup> 2014. in Brest was played match of 13<sup>th</sup> round between HC MESHKOV and HC LOVĆEN . For failure to send a statements before and after the match, according to Article 8.12 of the Competition Regulations SEHA League Commissioner brought up the following

#### **DECISION**

HC MESHKOV is punished with a fine 200 € (twohundredeuros)

At the match of 13<sup>th</sup> round between HC PARTIZAN and HC CROATIA OSIGURANJE ZAGREB, played in Beograd, HC Partizan player Vanja Ilić (No.3) was disqualified in 59<sup>th</sup> minute of the game. Due to the resulting disqualification, in accordance with Article 99.3 of the Competition Regulations, SEHA League Commissioner brought up the following

#### **DECISION**

**HC Partizan player Vanja Ilić is punished that he should not play one game.** The penalty relates to the first next match.

Due to the resulting disqualification Vanja Ilić was fined 500 €
