### **4) NOTIFICATIONS AND DECISIONS**

On March 27<sup>th</sup>, 2013. in Presov should have been played a match between HC Tatran from Presov and HC Izvidjac from Ljubuski.

On the scheduled match team Izvidjac has not arrived.

After establishing the facts, League Commissioner delivered the following decision:

- 1. The match is registered with the official result of 10:0 for HC "Tatran" Preshov, according to Article 46 and Article 87 of SEHA League Proposition,
- 2. HC "Izvidjac" is penalized by substracting 1 point on the Table of results according to Article 46 and Article 87 of SEHA League Proposition,
- 3. HC "Izvidjac" is punished with an amount of € 2,000 according to Article 87 of SEHA League Proposition.

#### **LEGAL REMEDY NOTE:**

To the decision of the Commissioner of the league it is possible to appeal to Competitive Commission as an appellate authority, within 24 hours of receipt of the decision, in accordance with Article 42 of the Regulations SEHA League. With the appeal should be paid a fee in the amount of € 1,000 to the account of HRS with note "SEHA League", according to Article 43 of the Regulations SEHA League

#### Penalty for Senjamin Burić

At the match of 18<sup>th</sup> round between HC SLOGA and HC BORAC M:tel, played in Doboj, Borac M:tel player Senjamin Burić was disqualified in 60<sup>th</sup> minute of the game. Due to the resulting disqualification, in accordance with Article 99 of the Competition Regulations, SEHA League Commissioner brought up the following

#### DECISION

#### HC BORAC M:tel player Senjamin Burić is fined 100 €
