### **4) NOTIFICATIONS AND DECISIONS**

Due to the absence of HC Vardar PRO players at a press conference organized on 11.04.2013., **HC Vardar PRO** is punished with a fine of **200** € in accordance with Article 100 of SEHA League Proposition.

Due to the absence of HC Metalurg players at a press conference organized after the finished match between RK Metalurg and RK Vardar PRO, **HC Metalurg** is punished with a fine of **200 €** according to Article 100 of SEHA League Proposition.

Due to the absence of HC Metalurg coach at a press conference organized after the finished match between RK Metalurg and RK Vardar PRO, **HC Metalurg** is punished by a fine of **500 €** according to Article 100 of SEHA League Proposition.

For unspotmanslike behavior of spectators against opponent team (players, coaches, spectators) during the match (throwing harmless objects - roll of paper on several occasions in the final match HC CO Zagreb - HC Vardar PRO) **HC Vardar PRO** is punished with a fine of **500 €** according to Article 97 of SEHA League Proposition.

For unsportsmanlike behavior of HC Metalurg spectators on match HC Metalurg - HC Vardar PRO against opponents team players, coaches, spectators, etc. during the match, and throwing hard objects that can cause injury (lighters, coins, wooden handles, etc., several times), **HC Metalurg** is punished with a fine of **1,000 €** according to Article 97 of SEHA League Proposition.

Due obtained disqualification in the final minute of the match HC CO Zagreb - HC Vardar PRO, HC CO Zagreb player no. 22 Josip Valcic, in accordance with rules of handball game No. 8:10 C, is banned for playing in SEHA League for a period of one (1) match. The penalty applies to I. (first) round of the season 2013/14.

Due to the resulting disqualification player Josip Valcic is punished by a fine of 100 €

#### LEGAL REMEDY NOTE:

To the decision of the Commissioner of the league it is possible to appeal to Competitive Commission as an appellate authority, within 24 hours of receipt of the decision, in accordance with Article 42 of the Regulations SEHA League.

With the appeal should be paid a fee in the amount of € 1,000 to the account of HRS with note "SEHA League", according to Article 43 of the Regulations SEHA League.
